APPROVAL OF COLLECTIVE BARGAINING AGREEMENT FOR ACCESS AND CARE CENTER EMPLOYEES

WHEREAS:

1. The previous contract between SORTA and the Amalgamated Transit Union Local 627 ("ATU") for the Access Operating Division expired March 1, 2021.
2. SORTA and ATU have collectively bargained for a successor contract with the term of March 1, 2021 through February 29, 2024.
3. The ATU bargaining unit ratified the successor contract by a vote of the membership on June 6, 2022.
4. Management recommends the SORTA Board of Trustees approve the collective bargaining agreement with the Amalgamated Transit Union Local 627.

THEREFORE, BE IT RESOLVED:

5. The SORTA Board hereby approves the new collective bargaining agreement for the period of March 1, 2021 through February 29, 2024 and authorizes and directs the CEO/General Manager/ Secretary-Treasurer or the CFO to execute the collective bargaining agreement between SORTA and the Amalgamated Transit Union Local 627.
