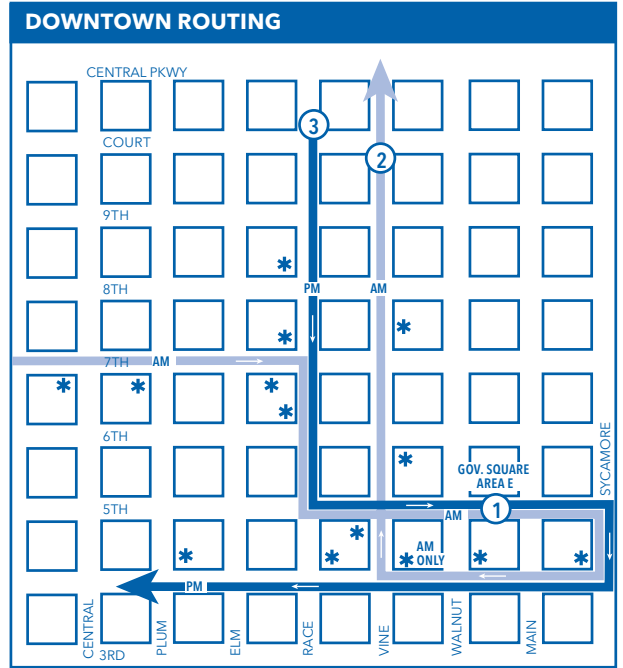
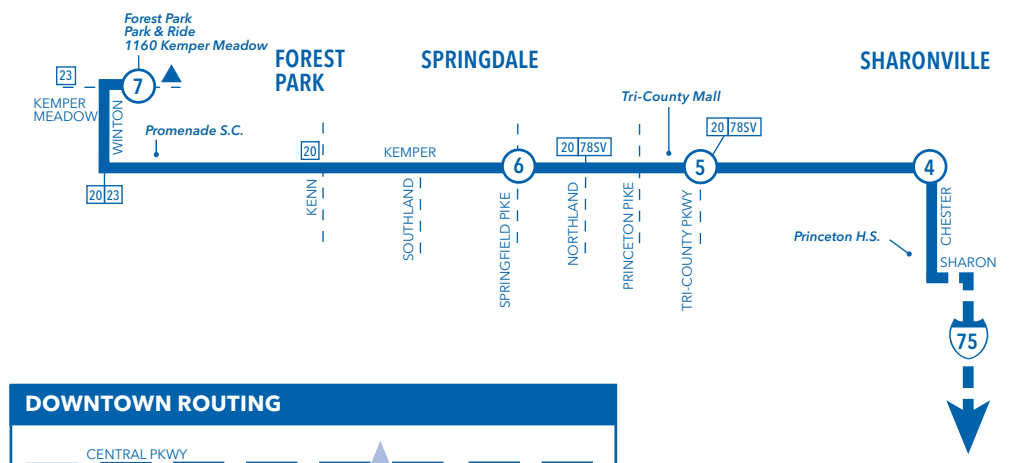
Note: Trips from the garage will operate out Spring Grove to Northside Transit Center to the Winton Rd. and Kemper Meadow Park & Ride.
