



### What is this pilot?

The EZConnect pilot project will provide regional one seat trips to riders who are ADA certified by Access, BCare or RAMP. This pilot project is not intended for local trips and will not replace the local service. EZConnect pilot project trips must begin in one transit agency service area and end in the service area of another transit agency.



The purpose of this EZConnect pilot project is to test the technology and feasibility of a shared ride regional paratransit services.


**An example** of an EZConnect pilot project trip is a trip from the Butler County Courthouse (BCare service area) to the VA Medical Center (Access service area).
